



Ford Benefits for GAF Factory-Certified Contractors

Ford X-Plan (for U.S. and Canada)

Eligibility: Master Elite, Certified

Master Select, Master

As a benefit of being a GAF Factory Certified Contractor, you and your employees are eligible to purchase new Ford vehicles at a discount. Eligible vehicles include current or prior model year new Ford or Lincoln vehicles currently in dealership inventory or ordered from production.

Enter GAF partner code NT673. Once you have read the eligibility rules and requirements and are ready to purchase your vehicle, follow these steps:

- Step 1:** Generate your PIN. A PIN (Personal Identification Number) is a unique numeric code required for each vehicle purchase under the X-Plan
- Step 2:** Visit your local dealer with your PIN and **immediately identify yourself as a GAF factory certified contractor GAF Partner participant.** Provide your PIN and the last 4 numbers of your Social Security Number to verify your eligibility.
- Step 3:** Provide proof of employment by providing a recent pay stub, company I.D., W-2 or company healthcare card. (*Note: business cards will not be accepted as proof of employment*). You may also **download a copy of the GAF membership eligibility letter from the GAF Certified Contractor Zone (CCZ)** <https://ccz.gaf.com>
- Step 4:** Select your new vehicle and request a copy of the dealer's vehicle invoice to confirm your X-plan price.
- Step 6:** Drive home in your new set of wheels!

Ford Fleet Program (not available in Canada)

Eligibility: Master Elite and Master Select ONLY

GAF Master Elite and Master Select contractors are eligible to purchase eligible Ford and Lincoln vehicles at a fleet discount using **GAF's FLEET IDENTIFICATION CODE (FIN) NX277 and Option code 56A***. To take advantage of this discount, download the GAF letter of fleet discount eligibility at : <https://ccz.gaf.com> **Take the letter to your local Ford dealer.** Eligible vehicles include 2015 model year vehicles ordered from production or purchased from authorized Ford or Lincoln dealer inventory. **Eligible 2015 fleet vehicles and discounts include:**

- Step 3:** Provide proof of Partner Program eligibility by downloading a copy of the **GAF membership eligibility letter from the GAF Certified Contractor Zone (CCZ)** <https://ccz.gaf.com> You will also be required to provide **proof of employment** at your company by providing a recent pay stub, company I.D., W-2 or company healthcare card. (*Note: business cards will not be accepted as proof of employment*).
- Step 4:** Select your new vehicle.
- Step 5:** Request a copy of the dealer’s vehicle invoice to confirm your X-plan price
- Step 6:** Drive home in your new set of wheels!
