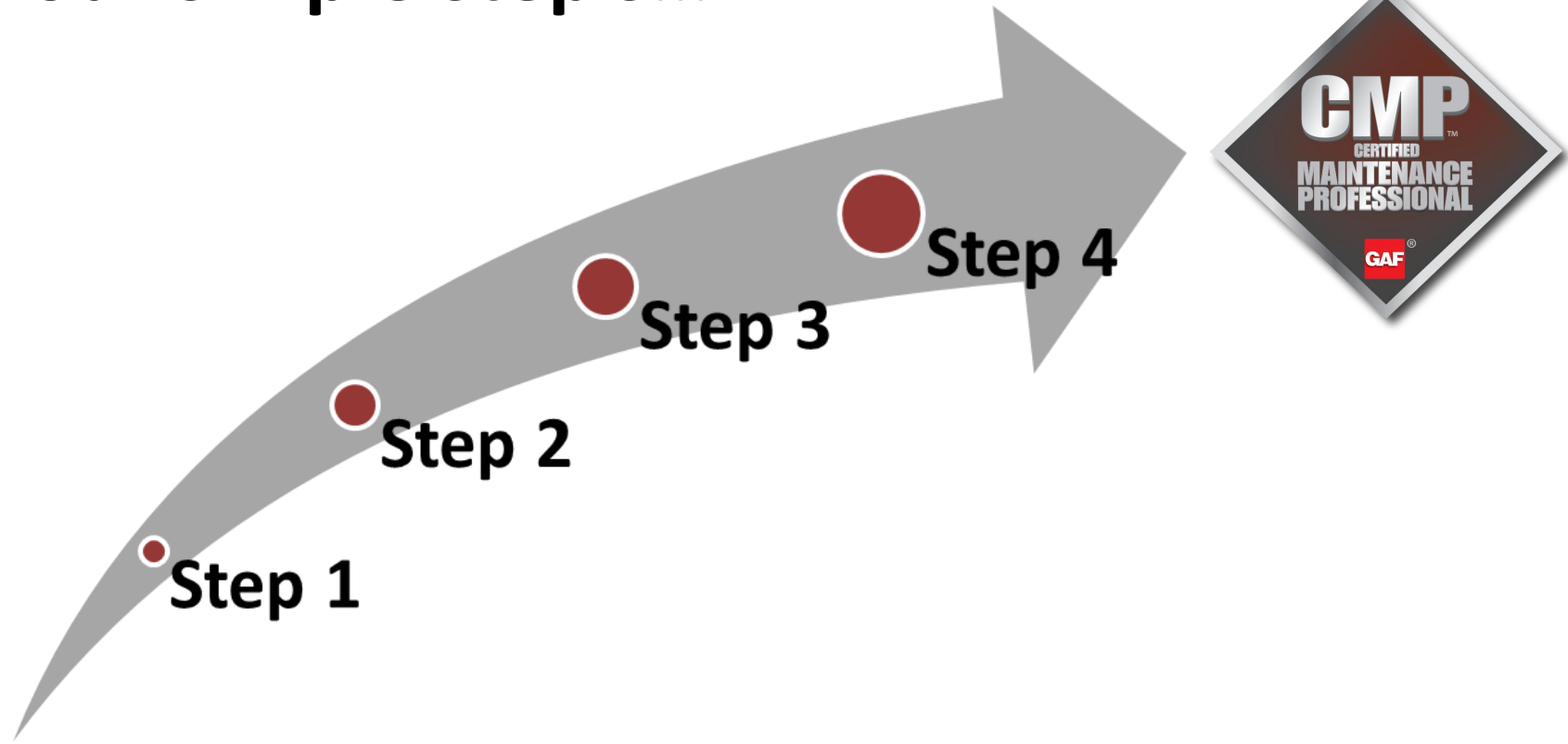




How to Become a GAF Certified Maintenance Professional (CMP)

Four simple step's...



Step 1: Complete the CMP or CMC Agreement Form



Provide the following information:

- Your name
- Company name
- Name of principal owner
- Phone number
- E-mail address
- GAF Territory Manager name

Step 2: Provide Payment



- Along with the application, provide a credit card or check in the amount of \$495



Step 3: Have your Territory Manager Sign the Agreement

ADDENDUM TO THE

GAF MATERIALS CORPORATION MASTER SELECT ROOFING CONTRACTOR AGREEMENT

This Certified Maintenance Professional Addendum (this "Addendum") is made _____, 20____ (the "Starting Date"), between GAF, a Delaware corporation ("GAF") and _____, whose address is _____ ("you" or "Contractor").

- Effect on Agreement.** This Addendum shall become a part of your GAF Master Select Roofing Contractor Agreement (the "Agreement"). Except as specifically set forth in this Addendum, the Agreement shall remain unmodified and in full force and effect.
- Defined Terms.** Capitalized terms used but not defined herein shall have the meanings specified in the Agreement.
- Certified Maintenance Professional.** Subject to the eligibility requirements set forth in section 4 and the inspection requirements set forth in section 5, GAF authorizes you to offer the WellRoof Advantage Program (as such program is modified by GAF from time to time in its sole discretion) (the "WellRoof Extension") to customers within the geographical area within which you are authorized to represent yourself as a Master Select Roofing Contractor pursuant to the Agreement (such area, the "Designated Territory").
- Eligibility Requirements.** To be eligible to offer a WellRoof Extension, you must meet and continue to meet the following eligibility requirements:
 - Must be actively enrolled and in good standing in the GAF Master Select Roofing Contractor Program.
 - Must submit payment in the amount of \$500 annually.
 - Must commit to register 5 WellRoof Extensions per annum to maintain status in program.
 - Must perform annual inspections and maintenance on all registered WellRoof Extensions
- Sales Requirement:** You agree to register at least five (5) WellRoof Extensions per contract year, which shall be defined as the twelve months following the Starting Date and each subsequent twelve month period thereafter.
- Inspection and Maintenance Requirements.** In order to offer a WellRoof Extension, you agree to the following inspection and maintenance requirements:
 - Submit annual Roof Audit/Inspection Report developed by GAF on the roof's installation anniversary.
 - Perform all items listed on the Roof Maintenance Program checklist provided by GAF (as the same may be modified by GAF from time to time in its discretion).
 - Provide 12 annual photos and submit to GAF.
- Effectiveness of WellRoof extensions.** The WellRoof Extension shall not become effective if you have failed to (a) perform any of the requirements set forth in Section 6 hereof or (b) satisfy any of the additional

requirements for effectiveness of the WellRoof Extension (as included in the program documents for the WellRoof Extension).

- Termination.** This Addendum shall terminate upon the termination of the Agreement. Furthermore, GAF may terminate this Addendum upon ten (10) days' written notice if you fail to comply with any of the terms of the Agreement or this Addendum.
- Counterparts.** This Addendum may be executed in two counterparts, each of which shall be an original but both of which together shall constitute one and the same instrument.
- Governing Law.** This Addendum shall be governed by, and construed in accordance with, the laws of the State of New Jersey applicable to agreements made and to be performed entirely within such state.
