### Volume Rebate<sup>3</sup>

The Volume Rebate is a program incentive based on the amount of net charge volume (total of all purchase volume posted to accounts minus any credits, other than payments, on accounts) that you submit during a calendar quarter.

#### The more you finance, the more you earn

- Merchants that submit \$150,000 – \$249,999 in Home Projects Visa credit card net charge volume in a calendar quarter will earn an incentive, which is calculated on 35 basis points (0.0035)
- Merchants that submit \$250,000 or more in Home Projects Visa credit card net charge volume in a calendar quarter will earn an incentive, which is calculated on 65 basis points (0.0065)
